Upgrading Your Membership



Step 3: Select Your SSIP Option

If you are upgrading to Gold you will be asked to select how you will fulfil the requirement for SSIP accreditation. If you already have a valid SSIP certificate from a third party SSIP member scheme (http://ssip.org.uk/members/), then select **Deem to Satisfy** and when completing your profile, upload your SSIP member certificate and Constructionline will provide you with Acclaim Accreditation through the Deem To Satisfy approach.

If you do not have a valid SSIP accreditation select the Acclaim option to complete the Health & Safety Section for accreditation.



Step 4: Payment

If you are upgrading to Gold (Level 3) from an existing Silver (Level 2) plan, any whole months remaining on your plan will be credited against your upgrade invoice.

The amount will be automatically calculated and shown on the summary (see below example).

Once you have checked the price of the plan, click on 'Continue' and then 'Confirm Upgrade'. You will then be asked to confirm your payment option.

Please note: the Credit Card/Debit Card method is preferred and will be visible on your account immediately. If you select 'Other ways to pay' this will take longer to process and will delay your verification.

Step 5: Completing Your Gold Submission

You will need to complete the following sections and submit them for verification. If you have completed these sections in the past, we advise revisiting each section to make sure you have submitted all relevant information.

Q1 - involves answering questions and providing evidence on how you deal with equal opportunities – You will need to provide relevant policies or a written statement explaining your procedures.

Q2 - requires you to answer questions and provide evidence on how you deal with environmental management. You will be exempt from some questions in this module if your organisation holds a certificate of compliance with UKAS (or equivalent) BS EN ISO 14001.

Q3 - involves answering questions relating to how you deal with quality management. You will be exempt from filling out this section if you hold UKAS (or equivalent) BS EN ISO 9001.

Q4 - this section provides Buyers with information relating to the extent to which your organisation can work with Business Information Modelling (BIM). If you do not work with BIM, or it is not applicable, continue to answer the questions as this will not exclude you from acquiring Gold accreditation. If you hold a PAS 11922 compliant UKAS accredited certificate, upload the certificate and you will be exempted from further questions in this section.

Please note: remember to submit each section for verification once completed.

Step 6: Complete the Supplementary Question Section

The information submitted in the Supplementary Question section extends beyond PAS 91 and has been designed in consultation with representatives from across the public and private sector.

The three sections will go into further detail in the following areas:

- Enhanced Health & Safety
- Equalities/Modern Slavery
- Quality Management.



Step 7: C4 Health & Safety

Remember to go back to the Health & Safety Section C4 and either complete the Acclaim questionnaire or upload your SSIP exemption certificate for Deemed To Satisfy (DTS).
