Select a Plan

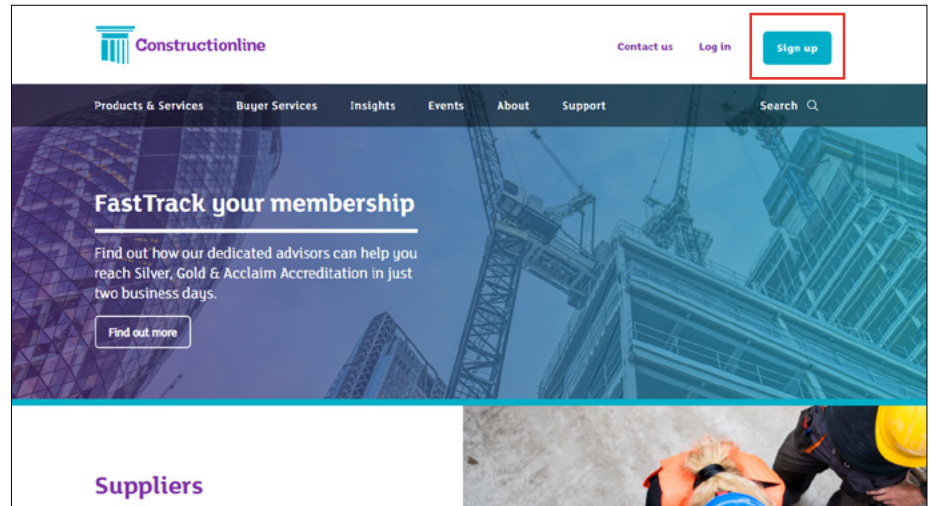
The following steps show you how to select a plan and pay for your Constructionline membership. Membership is renewed annually, and a renewal invoice will automatically be emailed to you.

The invoice will be sent to the Primary contact listed within your membership profile. Please ensure the Primary contact is the correct person to receive core membership notifications and invoices.

Step 1: Sign up to Constructionline

Go to the Constructionline website - www.constructionline.co.uk.

Step 5 - Silver & Bronze Membership with Acclaim Accreditation

Step 6 - Gold Membership

Our Gold Level accreditation mandates SSIP membership. This means that if you are selecting Gold membership you will need to select either **Acclaim Accreditation** or **Deem to Satisfy** (if you have a valid third-party accreditation – please note your Gold Membership will change to *Updates Required* when your third-party certificate expires and you will need to upload a new one).

If you already have a certificate for a third party SSIP member scheme then select **Deem To Satisfy** and when completing your profile, upload your SSIP member certificate and Constructionline will provide you with Acclaim Accreditation through the Deem To Satisfy approach.

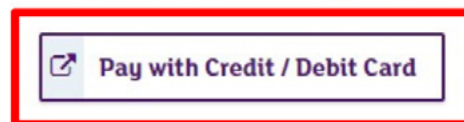

1 - PAY BY PHONE

To make your payment by telephone, click Confirm and call 01256 591219 and use your unique Constructionline membership number as the core reference and identifier. If you do not provide the full membership number, this will significantly delay the payment being allocated to your account and verification process completing.

2 - BACS

To pay by BACS, click Confirm and arrange for payment to be made to the account below and ensure that your **unique Constructionline membership number** is included in your payment reference. If you do not provide the full membership number, this will significantly delay the payment being allocated to your account and verification process completing.

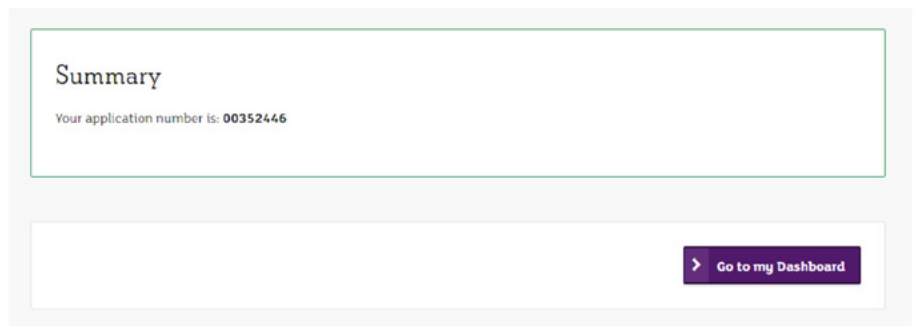

3 - DIRECT DEBIT

To set up a Direct Debit, click Confirm and complete the 'Direct Debit Form' attached to the payment section and submit this to your bank. Please ensure your **unique Constructionline membership number** is included within the Direct Debit reference. If you do not provide the full membership number, this will significantly delay the payment being allocated to your account and verification process completing.

Please note: If your invoice remains unpaid after the due date, our Credit Management Team will attempt to contact you. We will send reminder emails to the Primary Contact listed in your Membership Profile. If the invoice remains unpaid, and after several attempts have been made to contact you, your account will become locked and the following message will appear when logging in as a reminder that your payment is overdue.

Please be advised that your account has now been locked as your Constructionline Membership Fee is overdue by more than 90 days.

- If you prefer to make a telephone payment (this takes up to 48hrs to show on your account), please call 01256 383028 and have your payment card and membership number ready
